Summary of Activities achieved through Measuring up the North Grant :

The McBride Measuring up the North Committee gratefully acknowledges the approved grant and we are enthusiastic regarding the completion of the project and benefit to the community that has resulted.

The Village of McBride, in partnership with the Measuring up the North Project, provided a paved walkway through the park and paved access to the park pavilion, a covered open building which hosts many community events, including the weekly Farmers Market. Two specially designed wheelchair accessible picnic tables have been added as well as two easy access round picnic tables. All tables are accessible from the paved path. Trees have also been strategically planted to provide comfort and shade. The Village will maintain the park and provide handicapped parking. This project is a onetime capital improvement that the Village of McBride has made a commitment to maintaining and will have long lasting benefits for the residents of McBride and the Robson Valley.

The following is a summary of our activities throughout the life of the project:

-The park was surveyed and a design for the improvements was approved.

-The water and sewage lines were mapped to avoid damage to the infrastructure of the park.

-We submitted our requirements for the handicapped accessible picnic table.

-We received the tables and paid for them.

-We conducted a site walk through and tendered a request for a paving contractor to complete the paving requirements for the project.

-A paving contractor, Capital V Builders, was hired and a schedule of requirements and completion dates was drawn up





-Trees and shrubs were ordered and were delivered as they become available.

-Designs and specifications for signs designating wheel chair accessibility and handicapped parking areas were drawn up and incorporated into the park design.

- The appropriate signs were ordered, delivered and paid for.

- News releases have gone out to local media announcing the project and acknowledging the generous contribution to the project made by the Measuring up the North Fund.

- We submitted to the McBride Village Council the request for a motion regarding their endorsement of the 10 by 10 challenge.

- We received said motion and Council support of the principal of making our community accessible to people of varying degrees of ability.

- Capital V builders completed the cement work on schedule and on budget.

- The picnic tables were placed and the trees planted.

-Landscaping was completed to give the park a finished, attractive look.

- A plaque will be made acknowledging the improvements to the park were due to the partnership between the Village of McBride, the Measuring Up Fund, 2010 Legacies Now and the Province of BC. After the sign has been made we will have a celebration in the park with the unveiling of this project and our new playground.

-Notices were posted inviting community members to come help us celebrate Canada Day in "our new, more accessible park" with notices going to the local Seniors Centre and Home Support office.

Canada Day was celebrated in the Village Park with the Mayor, Chamber of Commerce representatives and a record number of the community coming out to help us celebrate!

We wish to reiterate our gratitude for the funding provided by the Measuring up the North Fund. As a small community the expense of such an improvement is outside of what the Village can afford. A Village/MUTN partnership in such a project provides an inspirational demonstration to the community showing the BC Government and community leaders working together to recognize physical and mental challenges faced by many members of our community and making a real commitment to improve the quality of life for all residents. The commitment by the BC Government





to help small communities make capital improvements that help the least able among us is truly appreciated and welcome.
