President's Message

am pleased to present SPARC BC's Annual Report for 2013/2014. I have served on SPARC BC's Board of Directors for the past eight years in a variety of capacities and will be moving to the role of Past President in the coming year. With every passing year, I have continued to be amazed and inspired by the creativity, commitment and innovation of the individuals and organizations that make up the non-profit and volunteer sector in BC.

As an organization, SPARC BC has had the privilege of working with a broad diversity of individuals and organizations committed to building communities that are equitable, inclusive, socially diverse and economically sustainable. Our work has included partnerships in the area of food security and healthy access to food, child poverty and healthy childhood development as well as strategies to address issues of housing affordability and homelessness. Through the work of our Research and Consulting group, we have also focused on research and action related to the needs of vulnerable seniors, people with disabilities, Aboriginal people and communities as well as low income families and children living in poverty.

This past year we have also had an active year in working with communities across the Province. This has included our work with LIRN BC (Learning Initiatives for Rural and Northern BC) as well as our work with Voluntary Organizations Consortium of BC (VOC BC), Volunteer BC and Vancity Community Foundation through the New Directions project that was funded through the BC Centre for Non-Profit Management and Sustainability. Through this project we have focused our efforts on the development of a Sector Impact Report and have worked together with others to build a shared narrative for the non-profit and volunteer sector in BC. Through our Community Development Education (CDE) program, we have also led workshops in a number of different communities and regions including the Alberni Valley, the Boundary Region, Castlegar, the Comox Valley, Parksville/Qualicum, Kitimat, Hazelton, Nelson, Shuswap, and Clayoquot.

Our partnerships through the Disability Without Poverty Network (DWP) and our work with First Call on the Child Poverty Report Card also continue to be important initiatives designed to help identify opportunities and actions needed to strengthen the social safety net. Our research shows that while other provinces across Canada have adopted specific measures and strategies to address issues of poverty and low income, BC has continued to fall behind. As a result, we see too many families and individuals who are unable to meet even their most basic needs like food and shelter. We know that, as a Province, we can do better and we must do better.

We have had another successful year in reaching out to communities and in supporting increased accessibility and inclusion through the delivery of our Parking Permit Program for People with Disabilities. This has included the successful introduction of an Accessibility and Enforcement Line as part of our annual Access Awareness Day

campaign. As well, we are pleased to report that with each passing year we see more local governments engaged in acknowledging and supporting our efforts around Access Awareness Day. We are also seeing more communities engaged in conversations and actions to ensure that their communities are as accessible and inclusive as they can be.

This year, I am also pleased to announce that the BC Aboriginal Network on Disability Society (BCANDS) is the winner of our 2013/2014 Deryck Thomson Award. Through the Deryck Thomson Award our goal is to recognize individuals and organizations that have made a significant contribution to social planning and social justice in BC. It is clear that the BC Aboriginal Network on Disability Society is a worthy recipient of this Award. Not only does BCANDS provide a strong and effective voice for Aboriginal people living with a disability but it continues to advocate for changes to our social safety net that would benefit everyone. On behalf of the SPARC BC Board of Directors, I want to thank the BC Aboriginal Network on Disability Society for their dedication and leadership in working to build a more just and healthy society for all. It is an honour to be able to recognize the tremendous work that they do.

As we reflect on the year that has passed, it is important to recognize the role and contribution of our members and donors. Over the past year, we have had significant success in growing and expanding our membership and donor base. In 2013/2014, more than 19,200 individuals joined our organization as new members or made a contribution to support our work with communities. As the President of SPARC BC, I am honoured by the trust, generosity and support that we continue to receive from our members and donors. We are fortunate to have this kind of support. I also know that it is the generosity and support of our members and donors that keeps us strong and that allows us to make a real difference in reaching out and supporting people and communities.

I want to conclude by recognizing the dedication, commitment and talent of everyone who has given of their time to contribute to the great work of SPARC BC. This includes the Board, staff and volunteers who share our same vision and who believe in the importance of the work that we do. About SPARC BC's Programs and Services

At its very essence, SPARC BC is about people and about communities. As an organization, our work is guided by the values of social justice, inclusion, integrity and learning. These values help to inform our work and guide our decisions.

SPARC BC uses evidence-based research, comprehensive and inclusive place-based planning, community dialogue, facilitation and community capacity building to advance policies and initiatives that will help strengthen the social safety net for British Columbians.

In addition to working to build local partnerships and relationships through convening and facilitating local meetings and workshops, we work to share our knowledge through our website and other online tools and resources. We also work to share our knowledge through the development of SPROUT publications and reports as well as through the active engagement of our different networks and partners.

The following provides some key highlights for 2013/2014:

- More than 57,000 individuals and organizations visited our website in 2013/2014 and we had more than 1,500 followers on Twitter;
- We received more than 19,000 calls from members and permit holders including more than 300 calls or inquiries to our Accessibility and Enforcement line;
- Staff in Research and Consulting completed thirty-two (32) research and consulting reports on a range of topics including housing and homelessness, food security for vulnerable populations, early childhood development, poverty and low income, as well as community and social inclusion.
- We received more than 3,200 responses to our Parking and Accessibility Survey with more than 45% of all respondents rating the overall accessibility of their community as excellent or very good. At the same time, approximately 1 in 3 respondents identified potential strategies or actions that could be taken to help improve the overall accessibility in their community.
- We convened or facilitated 23 community workshops and engaged more than 1,400 individuals or organizations from across BC through our CDE program and our New Directions Project that we delivered in partnership with VOC BC, Volunteer BC, and Vancity Community Foundation.
- We received acknowledgment and letters of support from more than 40 local governments as part of our Annual Access Awareness Day activities.

1. Call to Order

The President called the meeting to order.

2. Minutes from the Annual General Meeting, July 13, 2012

The President noted that the minutes from the Annual General Meeting held on July 13, 2012 were included in the Annual Report. The President called for a motion to adopt the minutes from the 2011/2012 Annual General Meeting.

3. President's Report

The President noted that the Annual Report includes a report from the President. The President shared some of her reflections over the past year and thanked the Board and staff for their hard work and dedication. The President also thanked SPARC BC's members for their on-going generosity and support.



Treasurer's Report

am pleased to present the Treasurer's Report for 2013/2014. Over the past year, SPARC BC has continued to have strong financial and operating results across all of our program and business areas. This includes the Parking Permit Program for People with Disabilities, Membership and Donations as well as the revenue generated through our Research, Planning and Consulting Services. Combined these programs helped to generate \$2,065,360 in revenue over the year with the following graph providing a picture of the revenue profile for our organization over the past five years.



It is clear that each of our different programs and initiatives contribute to the work that we do and help us to advance our mission. I also want to acknowledge and thank the BC Government for the assistance they provide through the BC Gaming Grant. This funding goes to support our annual Access Awareness Day activities, our outreach to communities around accessibility and inclusion as well as our community development education program.

In addition to the strong financial performance of our different programs and services, I am pleased to report that SPARC BC has been successful in generating an operating surplus of \$194,598 in 2013/2014. This funding will be reinvested back into our mission-driven work including our work in the area of accessibility and inclusion, income security and poverty reduction, as well as in community development education and outreach.

As a Board we recognize the important stewardship role that we play and know that we have a responsibility to provide the type of oversight and leadership needed to ensure that the programs and services that we provide are both sustainable and effective. Over the past few years we have made a number of investments in up-dating our office equipment and infrastructure in order to better meet the needs of our clients. This has included the introduction of our 1-888-718-7794 phone line which allows individuals and permit holders from across BC to reach us toll free.

This year, we have also made investments in updating our website as well as a number of security enhancements and other practical changes to our JADE database. These types of investments will help to reduce costs over the longer term as well as make it easier for our members and permit holders to find the information that they need. As we go forward, we will continue to explore other ways to use technology to improve productivity and to help us to do our business better and more efficiently.

Over the past year, our Finance and Audit Committee has also been actively engaged in working to establish a systematic approach for analyzing and evaluating risks and opportunities. This includes working to ensure that we have effective policies and controls in place to allow for the prudent management of the organization's assets and resources as well as working to establish clear policies and practices to allow for reliable reporting on results. We have also been looking at ways to ensure that our members and donors know how their contributions are being used and the types of results that are being achieved. As a Board, this is important to us. We know that it is the generosity and support of our members and donors that has helped us to make a real difference. To this end, I want to thank our members and donors for choosing to support SPARC BC — it is because of you that we are able to do what we do.

Profile of Members Nominated for Re-Election

Marilyn Belak (Dawson Creek)

Marilyn joined the SPARC BC Board of Directors in 2012 and has served on the Nominations Committee. Prior to joining the SPARC BC Board of Directors, Marilyn retired from Dawson Creek City Council after nine (9) years of service including a period as Interim Mayor in 2008. During her time on Council, Marilyn initiated a process to develop the City's Official Community Plan built around a Social Plan. Marilyn also established the Dawson Creek Housing Committee, a collaborative community-based partnership focused on addressing homelessness as well as working to address unmet housing needs in the community. Marilyn received the 2005 "Today's Woman Award" for "Woman of the Year, Impact and Influence in Northern BC." Marilyn also received several local Civic Leader citations and received the "misbehaving women" trophies three times. Marilyn also received two Aurora awards in 2008 and 2009.

Charley Beresford (Victoria)

Charley joined the SPARC BC Board of Directors in 2011 and has served on the Governance Committee. Charley brings a wealth of experience in, and understanding of local issues. As the Executive Director for the Columbia Institute, Charley is actively engaged in working with local governments and communities to build inclusive and sustainable communities that value social justice and that are healthier and happier places for people to live. Charley is also active in her community and has served on a number of local planning groups and advisory bodies including the City of Victoria's Social Planning and Housing Advisory Committee. As part of her political career, Charley provided leadership and policy advice on issues related to Health, Finance and Women's Equality, and helped to establish a Code of Conduct for Public Appointees.

Cameron Gray (Vancouver)

Cameron joined the SPARC BC Board of Directors in 2011 and has served on the Governance Committee. Cameron is the former managing director for the Department of Social Development for the City of Vancouver and the former Director of the Housing Centre. Cameron holds a planning degree and a diploma in urban economics and is recognized for his knowledge and expertise in the area of housing affordability and homelessness. Cameron is recognized for his commitment to social justice and for his significant contribution to the development of innovative strategies and approaches in the field of housing.

Profile of New Nominees

Christene Walsh (Kelowna)

Christene Walsh currently works as the Social Development Coordinator (SDC) with the Regional District of Central Okanagan. Utilizing an urban health approach, Christene is an important resource for non-profit and government service organizations while helping to promote harm reduction, prevention, treatment and enforcement services for individuals with complex needs. Christene also plays an important role in building partnerships and encouraging collaboration between service providers and brings significant experience in the area of community development, collaborative practice and the delivery of client-centered services.
